PARTICIPATION

- 1. The Santa's Grotto Memories Appeal ("the Appeal") is open to all UK residents aged 18 years or over.
- 2. You can send us your Submission by either completing:
 - (a) this online form; or
 - (b) a hard copy form, which can be collected from and returned to your nearest Dobbies store.
- 3. Photos included as part of an online Submission must be at least 1 MB per image.
- 4. Unfortunately, Submissions <u>cannot be returned</u> to you.

The closing date for Submissions is 5pm on [21 November, 2024]. Submissions received after this time will not be accepted.

COPYRIGHT

- 5. By uploading a photo as part of a Submission, you confirm that you have:
 - (a) taken it yourself and own the copyright in it; or
 - (b) received the express permission of the copyright owner to have the photograph used and shared by us in accordance with these Terms.



PERMISSION OF ANY PERSON PICTURED

- 6. By uploading a photo, you confirm that everyone who (i) features prominently and (ii) can be clearly identified in it has given you their express consent to let us use their image.
- 7. In the case of vulnerable adults or children under the age of 18, you confirm that you have obtained the express consent of their parent(s) or legal guardian(s).

THE CONTENT YOU SUBMIT

- 8. You agree not to upload a Submission that:
 - a) infringes the rights of any other person, including copyright and trademark rights;
 - b) is inappropriate, defamatory, obscene, harmful, violent or otherwise objectionable or offensive in any way;
 - c) contains any virus, corrupt file or other forms of malicious code or content that may harm a website or computer; or
 - d) violates any law, statute or regulation.

DOBBIES USE OF SUBMISSIONS

- 9. By uploading a Submission you:
 - a) give us permission to publish it in our stores, in Dobbies' Club Plus magazine, on our website, on social media channels and in press activity for the purpose of promoting the Appeal and our 160th Anniversary celebrations;
